1279.1 Central Beds Councillor Wells Cllr Wells gave a report:

Highway resurfacing: CBC has a new machine that re-surfaces the existing road surface called 'colas'. This is now being used and is cheaper and quicker than the previous system.

Old Flitwick leisure centre site – CBC has plans to use the site for sheltered housing for adults. It is expected there will be 60 units.

Thorn Turn Depot – The depot is now a year old and has achieved a 66% recycling rate. The 're-use' shop is doing very well and makes about £200 to £350 per day.

 - The Tuesday village bus service takes 1 hour and 10 minutes each way and is the only remaining bus service. The reason for raising the subject is that it is at high risk of being axed. People are not using the service due to the long travel time. CBC Cllr Baker said that he needs to know what demand there is for the service in Eversholt and would like the Parish Council to undertake a survey.

1314.3.1 Budget Report

The Clerk gave out the budget report showing expenditure to date.

1314.3.2 Annual Internal Audit 2018/19 - report The Clerk read out the report:

The Council is again able to claim exemption from external audit this year, due to the higher of gross income and expenditure in 2018/19 being below the £25,000 threshold. The Council has opted to exercise that entitlement and I confirm that on the basis of the figures seen by me the Council is entitled to claim the exemption. I would remind the Council that compliance with the Transparency Code is mandatory since it is the quid pro quo for exemption from external audit; Annex A of the Code, a copy of which was left with the Clerk sets of the details of the information that must be displayed and updated as necessary on the website. This means it is essential that the Council has control, directly or indirectly over access to the website in order that it can fulfil its statutory obligations regarding the posting of information, some of which is time-sensitive eg the notice of Electors' Rights.

Audit issues noted at this visit were as follows:

-For the first time in many years, the Council has incurred expenditure (legal fees) that included some £240 of VAT, however no reclaim of VAT was made during the course of the year. As this is public money, the Council is obliged to recover it and a reclaim should be instituted now.

-The Clerk currently uses a personal rather than a corporate e-mail address for the Council's business. Unfortunately, with the enactment last year of the General Data Protection Regulation (GDPR) this arrangement is no longer acceptable and a dedicated e-mail account, that can be as simple as epcclerk@gmail.com is now required. Not only will this ensure compliance with GDPR, it will also address the business risk associated with the current arrangements by allowing authorised 3rd party access to the council's corporate history and business communications in the event that the clerk is unavailable for whatever reason.

Notwithstanding the above, through examination of information provided on the council's website and the inspection of hard evidence and questioning, I tested all of the objectives of Internal Controls that I am required to consider and that are set out in the Annual Governance and Accountability Return (AGAR). Based on my findings in the areas examined, I am satisfied that in all significant respects the internal control objectives were achieved throughout the financial year.

Parish Council response:

-VAT was only incurred at the very end of the 2018/19 financial year hence the reason it had not been reclaimed. The Parish Council is also not currently registered to re-claim VAT as no VAT inclusive payments have been made during the current Clerks employment. The Clerk said that she will register the Parish Council with HMRC and re-claim the VAT in due course. (Action Clerk)

-The Clerk said that the Parish Council need to set up a corporate email address. Emails currently do go through the Clerks personal email account and the Clerk said that she will endeavour to rectify this over the coming year.

1367.1 Planning Applications:

1367.1.1

CB/19/03804/FULL - 61 Hills End - garage conversion to 2 bed bungalow with associated parking. The Parish Council opposed the application with a vote of 3 in opposition and 2 for with the following comments. The application is for the conversion of a property which has been partially erected under "Permitted Development" The original application was for a three car garage with a low profile ridge roof. However, it appeared to be in breach of the regulations as an inappropriate development as the structure was in the form of a dwelling with a high ridge roof. The Parish Council reported what they considered was a breach of regulations as it was not in the form which had been agreed. The developer was forced to stop and enforcement was to inspect the development. No further work was carried out on the building and it remains incomplete. The new application is for the development of the so called, existing garage which is not the case as the existing building is not complete and is not compliant with the original design. Permitted Development, as it is understood, allows for the erection of a building in association with existing domestic premises. The planning application for a separate dwelling does not fall in to this category, as it is for a separate dwelling in its own right. It is not the development as is; of an agricultural building but of a modern part finished structure built within the last twelve months, that is not in line with the plan of the original permitted development. It is believed, to approve this plan would set a serious precedent for the future as there are other properties in the village where a similar approach could be taken and could not be refused if this application is considered acceptable. It could be regarded as infill and not part of the village development plan.

1367.1.2 CB/19/03917/FULL – The Green Man, Church End – single storey rear extension. The Parish Council agreed to support the application providing that the Parochial Charity and the Conservation Officer are in agreement to the extension works. Cllrs did raise questions regarding parking and were informed that the tenants are looking to use the area to the rear of the existing car park (bonfire location) for additional parking. Secondly whether the toilets would be sufficient for the additional covers/capacity and the Parish Council were informed that the architect had raised no concerns.
