1449.1.1 CB/

1449.2.1 The Old Piggery

The Clerk said that a resident had reported their concerns about the development at the Old Piggery and this has been reported to Enforcement. Concerns included the ruining of verges and the dangerous slippery, muddy road, the prominent driveway kerb narrowing the road, noise and disruption from very early in the morning and lights being left on all night all around the building. Cllr Newport-Hassan said that the developers have said that they will make good the verges. Cllr Richardson said that they need to be done properly. Cllr Newport-Hassan agreed to contact CBC Cllr Baker and Highways to discuss this with them.
