## 1531.1 Planning Applications:

1531.1.1 CB/21/01261/FULL – Kelmscott House, 2 Higher Rads End –
enlargement of existing first floor rear balcony with new folding doors,
new folding doors to rear ground floor. Install new metal railings and
new electric sliding gates along with new pedestrian gate to front

boundary wall and alterations to access width.

The Parish Council has no objection to the application.

1531.1.2 CB/21/01940/FULL – Witts End Farm, Witts End – redevelopment of site and the erection of 5 dwellings

The Parish Council object to the application as it is over development of the site. The proposal is to convert the outbuildings in to five dwellings. Not only is this over development but to have five dwellings in this location is a cause for concern. There is the possibility of each house having a minimum of two vehicles (possibly more) access to the site is very narrow and on a blind bend where the road is very narrow. Under section Q there are strict guidelines about the development of farm out buildings.

1531.1.3 CB/21/00207/FULL – 5 Higher Rads End – demolish existing dwelling and replace with new dwelling
