Highways: CBC Cllr Baker has been examining highways jobs raised this year. He said that 30% have not been done by the contractor Ringway Jacobs and the less urgent the job the more likely it will never be done. CBC underspent last year so this is not a financial issue. Ringway Jacobs have been given notice and a new contractor will be employed.

Bin collections: there have been problems with bin emptying particularly with green waste with some bins not being emptied. CBC Cllr Baker said that he has been reporting some of the missed bins.

Finance: last year CBC received £178m in council tax and spent £11m on school transport, £5-6m of that was spent on private transport.

1648.2.1 CB/21/03329/FULL - The Paddock

The Clerk read out an email from CBC in response to the request for clarification of the policies stated in the refusal notice.

The proposed development represents inappropriate development in the Green Belt, which is, by definition, harmful to the Green Belt. The proposal would be detrimental to the openness and visual amenity of the Green Belt and an encroachment into the countryside, which would be detrimental to the character of the area. No factors which could amount to very special circumstances to clearly outweigh the harm to the Green Belt are evident. The proposal is therefore contrary to Policy SP4, SP7, HQ1 and EMP4 of the Central Bedfordshire Local Plan and Section 13 of the National Planning Policy Framework.

The Parish Council said that they were not sure this response was adequate. Cllr Miller agreed to look back through previous applications to identify whether the containers on site, previously mentioned, have been declared and can remain in place.

CBC Cllr Baker confirmed receipt of the report drawn up by Cllr Crichton and Cllr Collin. He said that there are various issues raised which are covered by various departments. Broken signs will need to be reported via 'fix my street' and verges reported to Matt Nash at CBC. He said that he sent the report to the Department Director but an adequate response has not been forthcoming. CBC Cllr Baker suggested that 5 priority items on the report be reported and then monitored, Cllr Newport-Hassan and Cllr Collin agreed to liaise to discuss which 5 items to report.

CBC Cllr Baker spoke about the speed limit proposals in the report and he suggested that the Parish Council start with requesting a 40mph limit along the length of the C100 to address the inconsistencies. If a reasonable petition is made including 10 signatures, the Committee will look at the request.

1661.3.2 Internal Audit Report

The Clerk read out the report and this was noted:

The Agenda for the 29 March 2022 council meeting includes an item 'review of policies' and the minute of that business shows that all current policies were reviewed and re-adopted; the current risk assessment document includes that review date so implicitly, it was included as part of the review. The requirement to carry out a review of the risks to which the council is exposed is an explicit legal duty under the Accounts & Audit Regs 2015 and as such, for reasons of transparency and for the avoidance of doubt, the agenda and the minute should always include a specific reference to demonstrate that the council has met its obligations. A better form of words for both might be 'to review the risk assessment and other policies ...'

Despite a second challenging year arising from the ongoing limitations due to Covid 19, the council and its diligent clerk have continued to maintain good standards of governance. I am pleased to be able to report that having tested all the aspects of the council's internal controls that I am required to consider, based on the information made available to me I am satisfied that in all significant respects, the internal control objectives were achieved throughout the financial year to a standard adequate to meet the council's needs.

1662.1.1 CB/22/01738/LB / CB/22/01737/FULL - Wakehams, Church End - Proposed shed in rear garden. The Parish Council has no objection to the application.

1662.1.2 CB/22/01654/VOC – 5 Higher Rads End – variation of condition numbers 2, 3, 4, 5 and 8 of planning permission CB/21/00207/FULL (demolish existing dwelling and replace with new dwelling). Variation

sought to discharge conditions for pre-occupation and precommencement and cover elements of the revised design. The Parish Council has no objection to the application.

1662.2 Other Planning Matters

1662.2.1 Issues for Enforcement

The Parish Council discussed some issues that need to be notified to Enforcement: (Action Clerk)

CB/21/03329/FULL – The Paddock, Higher Rads End. The applications for Change of Use to Builders Yard. This was refused as the land is agricultural. An issue was raised with CBC at the time of the application about 2 containers which are on site. It was agreed when the application was granted that the containers were for storage but were to be removed after a period. The containers have not been removed and have been relocated and had a roof put upon them, also the area referred to in the application CB/21/03329/FULL has been blinded with hard standing which should not be allowed if the land is to be regarded as green belt agricultural.

CB/21/01452/FULL – The Paddock, Higher Rads End. This application was withdrawn but the area was covered with hard standing and the new gateway was erected on the site in place of an existing five bar gate in the hedge. The new gateway encroaches on to the curtilage considerably further than the original fence line therefore does not have permission.

CB/20/00840/PADO – Coach House, change of use from office to dwelling. This was refused and one of the reasons for refusal was the access being blind as there was a high hedge along the highway curtilage at the entrance. The occupier subsequently removed the hedge and this was reported. No action was taken but it was proposed by CBC that the hedge was to grow back. The occupier has been working on the curtilage where the hedge was and is destroying any possibility of the hedge being able to regenerate, by strimming and chain sawing.
